

## Manuscript submission workflow in offsetting / publish & access agreements

- During the manuscript submission process all corresponding authors are obliged to supply information on funding and institutional open access agreements.

The author will be guided to a page where he/she must supply information about their funding or Open Access eligibility. This is a mandatory step before being able to complete the submission process.

- With regard to Open Access Agreements, the author will be presented with the following text:

“Karger has established agreements with cooperating consortia and institutions that include full or partial coverage of Article Processing Charges (APC) and/or Authors Choice™ publication fees, helping authors publish articles Open Access and comply with Open Access mandates. This means authors can publish Open Access without incurring any additional costs or with reduced APCs.”

and subsequent link to a page with the following information:

## Funding and Institutional Open Access Agreements

Karger Publishers is committed to helping authors benefit from Open Access agreements and meet the requirements of the Open Access mandates of all funding bodies. Depending on the funders' and institutions' requirements, research may be published as an Open Access article (Gold Open Access) or archived in an Open Access repository such as PubMed Central (PMC) or an institution's own repository (Green Open Access), or both.

Authors should always indicate their affiliation with an institution covered by an **Open Access agreement** and **funding** sources during submission and should include information on their grants in the Funding Sources section of their papers.

A list of institutions with Open Access agreements covering part or all of Article Processing Charges (APCs) and a list of some funders with Open Access mandates can be found below.

Corresponding authors affiliated with the following institutions are eligible for full coverage by their institution's library of the Authors Choice™ publication fee and all additional publication costs for original research and systematic review articles published in hybrid journals (subscription journals with an Open Access option).

Authors Choice™ is the fully Open Access Option for Karger hybrid (subscription) journals.

- The author is then required to declare themselves either
  - “eligible” and enter the name of their institution in the submission form, or
  - “not eligible”, or
  - “opt out despite being eligible”
- Upon acceptance of an article for publication the Karger Editorial Office will check the affiliation information resp. funding eligibility of the corresponding author. ‘Not eligible’ declarations will also be checked; ‘opt out’ declarations will not be checked.

Following acceptance for publication, Karger Editorial Office will inform the corresponding author about the Creative Commons license option. The standard Creative Commons license for open access publication in Karger journals is CC BY-NC for hybrid open access in subscription journals, and CC BY in Gold Open Access journals. Where required by funder, CC BY will be offered for hybrid open access articles, in which case any exceptions will be specified by separate agreement.

- Karger will provide to the consortium quarterly reports of published articles by corresponding authors of member institutions.
